## **Frequently Asked Questions**

Why don't people just stop drinking or using drugs? Addiction is not simply a choice; it is a chronic disease that is cunning, deceitful, and destructive. Addiction is a "thief" that robs one of their ability to reason. Most people want to stop, they just do not know how to on their own.

Does the program offer offenders an easy way out of serving jail time? NO! Participants serve jail time. After jail, some enter inpatient or intensive outpatient treatment; all complete an intensively supervised probation sentence for a period of time determined by the District Attorney's Office. Additional jail time may be ordered as a sanction for program violations.

Are participants held accountable for past offenses? YES! Their jail time is determined by the number of previous convictions.

Are candidates screened before being accepted into DUI Recovery Court?

YES! They must first be "approved" for the program by the District

Attorney's Office who conducts an extensive background check. Then
they are interviewed by the Probation Office and Court staff in addition
to clinically assessed by the Treatment Provider.

#### **Eligibility Guidelines**

- Currently charged with two pending DUI 1<sup>st</sup> offenses or -
- Currently charged with DUI 2<sup>nd</sup>, 3<sup>rd</sup>, or 4<sup>th</sup> offense or -
- Currently charged with Violation of Probation while on probation for a DUI conviction
- Current charge does not include a fatality or serious injury
- No history of conviction for violent offenses
- Meet criteria for moderate to severe substance use disorder
- Voluntarily agree to participate in DUI Recovery Court

### **DUI Recovery Court receives no county funding.**

It cost the Court \$32 per day to provide services to a participant. It cost taxpayers \$85 per day to house an inmate in the Williamson County Jail, where nearly all participants would end up if the program did not exist.

### **Court Requirements**

- Identify a mentor and attend three self-help meetings each week
- Weekly meetings with Presiding Judge, Court staff, and Treatment Provider
- At least two screenings for alcohol and/or drug use each week
- Complete a comprehensive recovery treatment plan
- Fulfill all obligations of probation
- · Attain or maintain full-time employment



Williamson County DUI Recovery Court

**Gives those affected** by substance use disorders an opportunity to change their life through recovery. Those who successfully complete the program restore relationships with loved ones, bring an end to generational disorders, become positive, contributing members of our community, and increase public safety by not driving while impaired.

94% of all participants have successfully completed the program

150+ participants have graduated from the program

No participant has ever been re-arrested for DUI while in DUI Recovery Court
